

Richland-Bean Blossom Community School Corporation
 Self Protection Plan for Devices (Student Chromebooks)
 Revised 12/2016

Each student of Richland-Bean Blossom Community School Corporation (RBBCSC) will be issued a Chromebook as part of his/her textbook rental for the 2016-2017 school year. It is our expectation that the student will be responsible for the [care](#) and protection of this electronic tool.

RBBCSC has chosen to offer a protection plan for the accidental damage of this device. Prior to a student receiving his/her Chromebook, RBBCSC must receive this form filled out and signed by the student's legal parent/guardian along with the protection plan Annual Premium fee or designation of the protection plan waiver checked below. The costs are outlined below. Claims and deductibles are applied to individual students and not to families. After the third claim, the student is liable for the full repair or replacement cost of the device.

If a student withdraws from RBBCSC and then re-enrolls later in the current school year, the coverage purchased at the student's initial registration will be reinstated along with the number of claims made prior to withdrawal. The protection plan will be active from the time it is paid and the device issued until either the device is officially remitted to school officials at the end of enrollment or the end of the 2016-2017 school year whichever comes first.*

The Chromebook or any of its accessories that are lost (whereabouts unknown) or intentionally damaged is the responsibility of the student and parent involved in the loss of property. The user may not be given another device or accessory to use until the replacement cost of the lost/damaged device or accessory is paid to the school.

Events that may not be covered by this protection plan include, but are not limited to: lost device, theft, damage due to negligent or malicious actions of the student such as transporting outside of protective case, food and drink around the device, exposure to extreme heat or cold (left in the car), or fail to follow any rule or precaution set forth in the Device Policy Handbook.

Events that may be considered accidental damage by this protection plan include, but are not limited to: events at home that result in property damage caused by wind, fire, and water, events where a device is in a car that is involved in an accident, events that may be created by parents, siblings, or classmates which result in damage to the unit (the other party may be held responsible for damages depending on the evidence), other events as determined by the School/Corporation administration.

This protection plan will pay to repair or replace the unit as a result of accidental damage. Current homeowner insurance or auto insurance policies will be the first insurer when applicable. This protection plan may be used to cover costs beyond the scope of these insurance policies including deductibles that apply to those policies.

This protection plan is optional and may be refused by the parent/guardian. Students who agree to purchase this protection plan also agree to keep the unit in the protective case when not in use and/or transporting.

If a protection plan is not elected by the parent the following charges can and will occur. Any item under \$25 will be billed individually as not to incur a claim.
